In this model, each undergraduate student has the opportunity to choose a tutor for the whole period of his/her undergraduate studies. Students meet their tutor twice per semester, prepared by written reflexion reports, and discuss issues of study or career planning, daily organisation but also important milestones such as going abroad. In 2016, 500 students and 120 university teachers were participating in this new, voluntary programme, that has been successfully evaluated in its first round (Balsam et al. 2014; 2015).
